IN THE COUNTY COMMISSION OF PLATTE COUNTY, MISSOURI

AN ORDER ADOPTING ADDITIONAL REGULATIONS TO CONTROL VEHICULAR TRAFFIC UPON THE PUBLIC ROADS IN THE UNINCORPORATED TERRITORY OF PLATTE COUNTY, MISSOURI

WHEREAS, this Commission has authority pursuant to Section 304.130 RSMo. to adopt regulations to control vehicular traffic upon the public roads in the unincorporated territory of Platte County; and

WHEREAS, Notice was published in The Weston Chronicle and The Platte County Citizen, two newspapers of general circulation within Platte County, on October 19, 2022 and October 26, 2022 providing notice that public hearings regarding these regulations would be held by the Platte County Commission on November 7, 2022 at 10:00 a.m., November 21, 2022 at 10:00 a.m. and December 5, 2022 at 10:00 a.m.; and

WHEREAS, additional notice of the public hearings was posted in four (4) conspicuous places in the County at least fifteen (15) days prior to the public hearings and an Affidavit regarding those postings is on file with the Commission; and

WHEREAS, the Commission has held public hearings regarding these traffic regulations on November 7, 2022, November 21, 2022 and December 5, 2022; and

WHEREAS, on November 29, 1994, the Commission adopted County Commission Order No. 27-94 establishing speed limit regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on December 18, 1997, the Commission adopted County Commission Order No. 36-97 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on June 17, 1999, the Commission adopted County Commission Order No. 38-99 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on June 14, 2001, the Commission adopted County Commission Order No. 28-01 establishing additional traffic regulations in the unincorporated portion of Platte County; and

WHEREAS, on December 13, 2001, the Commission adopted County Commission Order No. 57-01 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on December 19, 2002, the Commission adopted County Commission Order No. 60-02 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on January 15, 2004, the Commission adopted County Commission Order No. 01-04 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri;

WHEREAS, on July 18, 2016, the Commission adopted County Commission Order No. 2016-CO-224 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, on January 3, 2022, the Commission adopted County Commission Order No. 2022-CO-001 establishing additional traffic regulations in the unincorporated portion of Platte County, Missouri; and

WHEREAS, the Commission believes it is in the best interests of the County that additional regulations be established to supplement County Commission Orders No. 27-94, 36-97, 38-99, 28-01, 57-01, 60-02, 01-04, 2016-CO-224 and 2022-CO-001 with regard to regulating vehicular traffic upon the public roads in the unincorporated territory of the County.

WHEREFORE, the Platte County Commission does hereby order as follows:

1. That Schedule III, titled "Parking Restrictions" of the Traffic Schedules set forth in Chapter 305 of the Platte County Code shall be amended such that Exhibit A attached to this Ordinance shall be the new "Schedule III".
2. Any person who violates any of the regulations established in this Ordinance shall be guilty of a misdemeanor and may be punished by a term of imprisonment not to exceed one (1) year, or by a fine not to exceed \$1,000.00, or by both fine and imprisonment.
3. These regulations shall be codified, printed and distributed for public use by the Clerk of the County Commission.
4. Adequate speed limit signs shall be posted at the beginning and ending point of each speed limit area designated by this Ordinance.
5. This Ordinance shall be effective immediately upon passage.

Exhibit "A"

SCHEDULE III. PARKING RESTRICTIONS

No parking shall be allowed on the following streets:

<i>Location</i>
Running Horse Road: From 120 th Street north the city limits of Platte City
NW 136 th Street: From Running Horse Road East to KCMO City Limits
Blair Road: From 45 Highway to Eastside Drive
Crossroads: From Blair Road to Parkville city limits
Eastside Drive: From Parkville city limits to the Weatherby Lake city limits
Graden Road: From 45 Highway to Blair Road
Kerns Road: From Blair Road to city limits of Weatherby Lake
NW 50 th Street, northwest side: From 6560 NW 50 th Street to 6712 NW 50 th Street
South Crooked Road: From Missouri Highway 45 south to Raintree Drive
NW 76 th Street: From NW Fox Road to NW Schuyler Drive North side of street during snow removal operations
Village Circle Drive: All along outer side of the circle portion of this roadway during snow removal operations
